The Florida City and County Management Association is pleased to announce the **2012 Awards Program**. All awards will be selected by the FCCMA Awards Committee and be presented at the Annual Conference in June.

The FCCMA Awards Program is patterned after the ICMA Awards Program.

### Award Categories

The **Award for Career Excellence** recognizes an outstanding local government administrator who has fostered representative democracy by enhancing the effectiveness of local elected officials and by consistently initiating creative and successful programs. **Eligibility:** Voting member of FCCMA with a minimum of 10 years senior-level management experience. *Requires the endorsement of a past or present elected official.*

The **Michael J. Roberto Award for Career Development** will be presented to a voting FCCMA member who has made a significant contribution to the development of new talent in professional local government management (internships, mentoring, etc.). This award is a



memorial to Mike Roberto, a past president of the FCCMA, and a recognized leader in the development of public management careers.

An **Assistant for Excellence in Leadership** will be presented to a local government management professional who has made significant contributions toward excellence in leadership while serving as an assistant (regardless of title) to a chief local government administrator. **Eligibility:** FCCMA member and endorsement of CAO. Must be a full-time assistant reporting to a chief local government administrator and who has been responsible for significant administrative duties for at least one year (not including internships in conjunction with an academic program).

The **Award for Program Excellence** will recognize communities that develop innovative programs or processes that improve the quality of life for citizens. These programs and processes may include advancements in technology, communication, sustainability, or improved partnerships and must have been developed in the past calendar year. Awards will be given in four population categories: less than 20,000, 20,001-50,000, 50,001-150,000, and 150,001 and up.



### Application Procedures

To apply for any of the awards, complete the application form and return it along with any supporting documentation to Carol Russell at FCCMA, 301 S. Bronough, Suite 300, Tallahassee, FL 32301. **Submittals must be received by 5:00 p.m. February 24, 2012.** Nominations may be made by peers, local city/county managers' associations, other associations or by self-nomination.
