

Starting a Water Quality Journey

Every journey has a beginning. Mine began at a conference a couple of years ago. The conference focused around the importance of water in the planning world. Maybe not immediately the most fascinating of topics but I came away from this conference with a perspective that really changed my approach to water and water quality. The presenter talked about water issues and said that there is not a single jurisdiction in this nation that does not have a water problem. It could be too much, not enough, inconsistent, in the wrong place, in the wrong form, contaminated, expensive, poor quality or not fully accessible along with a multitude of other issues. Because of the complexity of these issues, a holistic approach to "everything water" is critical to success.

Applying this to my jurisdiction, we have too much (through summer rains, tropical activity, high tides etc.), not enough during our winter dry season, impaired quality of some of our surface waters from a variety of contaminants and a

relatively high cost of potable water in some areas.

Charlotte County is on the southwest coast of Florida, has two rivers and many tributaries running into the second largest natural harbor in Florida (Charlotte Harbor). We have a multitude of canals giving boater access to the harbor, giving us a total of over 800 miles of natural or man-made shoreline in the county. We are flat with elevations ranging from sea-level to approximately 60ft above sea level in our more inland area. Our main source of drinking water is the larger of our two rivers.

Much of our tourism industry is water based in some form with our fantastic beaches, fishing, boating and eco-tourism opportunities making the preservation and improvement of our water incredibly important. People move to our county for access to the water and we have many water dependent businesses. Water quality has always been a focus of our board but in 2019, they made it a priority and set a goal as part of their strategic plan to improve water quality.

We had already been making great progress with water quality. We have always had a very aggressive septic to sewer program, stormwater programs and many environmental successes but there had never been a holistic approach to our water and water quality issues.

FLGISA Webinar Series: Cyber Kinetic Attacks

**Tuesday, June 8, 2021
10:00 am to 11:00 am ET**

Our jurisdictions across the state have been keenly aware of the recent escalating cybersecurity threats. Some of the world's most egregious hacks have taken place within these last few months, and substantial vulnerabilities have recently been found in various critical hardware and software platforms that we count on every day to keep us safe and secure from outside intruders. Thousands of organizations across the world continue to fall victim each day, including many of our own local governments. In fact an escalation of attacks has continued under COVID and is forecast to increase. For these reasons, the **FLGISA is hosting a regularly scheduled webinar series to address the various cyber threats we are all currently facing**, and help increase our general understanding and knowledge across the board, whether you are in the IT field or not, or just wanting to learn more.

On our upcoming webinar, Waterleaf International will be giving a high-level overview on **Cyber Kinetic Attacks** – what are they? Who are they? Why are they targeting municipalities, and what do they seek to gain? How does it affect our operations, our financial systems and our public safety? What are the most prevalent kinds of attacks, obvious vulnerabilities and what can you expect on the horizon – and most importantly of all – why should you care, and how can you protect yourselves against these?

We are pleased to introduce these speakers for this session:

- **Maj. Gen. Ed Wilson USFA (ret)**, who recently retired from nearly four decades of government service and founded Pinnacle Strategic Consulting, LLC, which is focused on consulting, board service and public speaking in areas related to cyber, space and intelligence. He served active duty in the U.S. Air Force and as a senior government political appointee in the Department of Defense. Having commanded at all levels from squadron to Numbered Air Force, he spent over three decades in the military at the forefront of cyber and space operations. He then served as the civilian Deputy Assistant Secretary of Defense for Cyber Policy supporting the Secretary of Defense and other senior leaders with policies, strategies and plans to guide DoD's ability to operate in cyberspace.
- **Adam Sewall**, is the Founder and CEO of Waterleaf International LLC. Waterleaf is comprised of engineers, scientists and program managers focuses on cybersecurity, network engineering and data sciences and serves the DoD, Civilian Agencies, SLED and Enterprise. Adam's has been CEO of several technology companies with a focus on telecommunications as well as cybersecurity. He is a board member of Edgemesh as well as having served as a board member for Tradeworx/TheSys Technologies, Marteleron, T3 and others. His background in Cybersecurity goes back to 1990 with responsibilities for network security at telco's and offensive cyber for the government.
- **Dr. Ramon C. Barquin**, President of Barquin Solutions LLC, A Washington DC based IT consulting group and wholly owned subsidiary of Waterleaf International. Dr. Barquin's career in the information technology industry spans five decades over five continents. His career with IBM included technical assignments and corporate management, with overseas postings and responsibilities in Asia and Latin America. Afterward, Dr. Barquin served as President of The Washington Consulting Group, where he had direct oversight for the performance of major consulting contracts for the U.S. government. Dr. Barquin is Chairman of the Board of

the Atlantic College, and from 2000 to 2008, served as a Director of the Washington Hospital Center. He is a member of the Department of Homeland Security's Data Privacy and Integrity Advisory Committee and the Digital Government Institute Advisory Board. An electrical engineer and mathematician by training, Dr. Barquin holds a Ph.D. from MIT. He is the author and editor of six books and more than 200 technical and management publications. Dr. Barquin has held faculty appointments at MIT, the Chinese University of Hong Kong, and the University of Maryland.
