### THE 30-MINUTE FORMULA: HOW TO WHIP UP A NEWSLETTER SUBMISSION

Quick question: how many of us have time to write an article for this newsletter?

That's what we thought.

But learning from one another is a big reason we joined FCCMA.

That's why we've shortened our "Management in Motion" feature to help you manage the time-crunch and write a succinct, engaging piece in about 30 minutes. Here's how:

**Tip 1: Don't get hung up on "big" ideas.** If you have a groundbreaking project, by all means, share. But smaller, day-to-day programs can be just as inspiring and are often easier for members to activate.

**Tip 2: Outline first, then write.** Some of us get keyboard paralysis before we begin. A brief, three-prompt outline can help you structure your thoughts:

1)(Program) was developed to (solve this problem/leverage this opportunity).

2) The three most effective program elements were (planning committee, internal buy-in, external engagement, partner involvement, PR/communications, etc.) and here's why.  
3) (Program) resulted in (outcomes).

**TIP 3: Keep it high-level, not in the weeds.** Choose your data points wisely and try to avoid lengthy, overly detailed descriptions. Keep your eye on the big picture and remember, if someone wants to know more, they'll reach out.

**Tip 4: Ask someone to be your "editor."** Choose someone who will give you candid feedback and offer suggestions to make your submission even better. Consider your communications director, admin, or even a fellow FCCMA colleague.

Are you ready? Of course you are. And we can't wait to see the submissions roll in!
